

How To Sign Your Title – Connecticut

CLAIM

Here are step-by-step instructions to properly complete, endorse and mail your title document to us. Please follow these steps carefully.

1. On your original title, please enter your mileage in the ODOMETER READING area
2. Print your name exactly as it appears on the title in the NAME OF SELLER(s) area
3. Sign your name exactly as it appears on the title in the SIGNATURE OF SELLER(s) area

Note: If more than one person is listed as Owner, both should print and sign on the same line.

If the titled owner names are separated by “or”, only one signature is required

Please contact your Claim professional if you have any questions.

This Connecticut title example is provided as a guide only. Complete, sign and submit your original title.

NO SELLER SHALL ASSIGN TITLE OF A VEHICLE WITHOUT INSERTING THE BUYER'S NAME AND ADDRESS ON THE ASSIGNMENT AND WARRANTY OF TITLE.
